### **PUBLIC COMMENT:**

-Mr. Thompson stated his opinion that the personnel subject(s) listed for Closed Session on the Agenda should discussed in Open Session if they are in regard to the recent exit of Steve Thomas.

#### TREASURER'S REPORT:

- -Treasurer Murray reviewed the lists of computer checks totaling \$816,115.22 and manual checks and electronic transactions totaling \$8,079.24 for a grand total of \$824,194.46 in disbursements for November and December 2017. Motion was made by Commissioner McDermott, seconded by Commissioner Walsh to approve the disbursements for November and December 2017 Roll Call: Ayes: Commissioners McDermott, Sansone, Walsh and Doss; Nays: None; Absent: Commissioner Entler.
- -Joe reported that fund balances for the close of November totaled \$2,594,966.99. Reports show that the balance invested in the Money Market funds at Forest Park National Bank as of December 19, 2017 were \$145,043.74 and the OSLAD Money Market account shows a balance of \$200,368.51. \$2,191,024.29 remains invested in our accounts with the Illinois Park District Liquid Asset Fund. Motion was made by Commissioner Walsh. seconded by Commissioner McDermott, to accept the Financial Statements for the close of November 2017. Roll Call: Ayes: Commissioners McDermott, Sansone, Walsh and Doss; Nays: None; Absent: Commissioner Entler.

# **MAINTENANCE REPORT:**

-Superintendent Buckley reported that the Christmas decorations are all up and the fence was installed near the DayCamp Building. The will be taking the pool pump out and having it repaired.

### **DIRECTOR'S REPORT:**

-Director Piekarz reported that things are going well with construction of the Roos Recreation Center. He showed them the logo that will be used for the Center for stationery, banners and shirts. Painting is just about done and pillars are installed. The VIP party will be held on May 19, 2017. -Larry said that he will be assuming the duties of representative to the WSSRA Board, however official Board action is required. He said that any commissioner who would like to be alternate is welcome to do so, otherwise Andrew Doss will assume that roll.

- -Commissioner McDermott asked what the policy is with regard to opening the multi-purpose field during the winter, particularly on days when the weather is conducive. Director Piekarz said that it is normally closed during the winter, but we try to remain flexible with all of the facilities taking into account the weather and other safety issues.
