

Ordinance # 231116B

**AN ORDINANCE LEVYING TAXES FOR
THE PARK DISTRICT OF FOREST PARK,
COUNTY OF COOK AND STATE OF ILLINOIS
FOR THE YEAR 2023**

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE PARK DISTRICT OF FOREST PARK, COOK COUNTY, ILLINOIS:

SECTION I. That the sum of THREE MILLION FOUR HUNDRED SIXTY-SEVEN THOUSAND FOUR HUNDRED FORTY-SEVEN (\$3,467,447.00), or so much as may be authorized by law, is hereby assessed and levied for the anticipated objects and purposes specified below, on all taxable property within the Corporate limits of the Park District of Forest Park at full, fair cash value as the same is assessed and equalized for State and County purposes for 2023.

SECTION II. Pursuant to Section 4-4 of the Park District Code (70 ILCS 1204/4-4), neither the Budget and Appropriation Ordinance of the Park District for the current fiscal year beginning on May 1, 2023 and ending on April 30, 2024, nor any other Budget and Appropriation Ordinance of the District is intended or required to be in support of the tax levy made by this Ordinance.

SECTION III. That the Secretary is hereby directed to file with the County Clerk of Cook County, Illinois, on or before the last Tuesday in December, A.D. 2023, a copy of this Ordinance, duly certified by the Secretary of the Board of Park Commissioners of the Park District of Forest Park as to its enactment, accompanied by the Certificate of the Presiding Officer as to compliance with the Truth in Taxation Law, and said County Clerk is hereby directed to extend taxes sufficient.

SECTION IV. That this Ordinance shall be in full force and effect from and after its adoption as required by law.
